NATIONALLY, MBCC CONTINUES IN ITS ROLE AS A COMMUNITY PARTNER ON THREE NATIONAL PFAS HEALTH AND EXPOSURE STUDIES. TWO OF THESE STUDIES ARE FUNDED BY THE NATIONAL INSTITUTE OF ENVIRONMENTAL HEALTH SCIENCES, AND THE THIRD IS FUNDED BY THE CENTERS FOR DISEASE CONTROL AND PREVENTION AND THE AGENCY FOR TOXIC SUBSTANCES AND DISEASE REGISTRY. THROUGH THESE PARTNERSHIPS, MBCC IS CONTRIBUTING TO A BROADER SCIENTIFIC UNDERSTANDING OF THE SOURCES OF PFAS EXPOSURE AND POTENTIAL HEALTH
