NATIONALLY, MBCC CONTINUED IN ITS ROLE AS A COMMUNITY PARTNER ON TWO NATIONAL PFAS HEALTH AND EXPOSURE STUDIES. ONE STUDY IS FUNDED BY THE NATIONAL INSTITUTE OF ENVIRONMENTAL HEALTH SCIENCES, AND THE OTHER IS FUNDED BY THE CENTERS FOR DISEASE CONTROL AND PREVENTION AND THE AGENCY FOR TOXIC SUBSTANCES AND DISEASE REGISTRY. THROUGH THESE PARTNERSHIPS, MBCC IS CONTRIBUTING TO A BROADER SCIENTIFIC UNDERSTANDING OF THE SOURCES OF PFAS EXPOSURE AND POTENTIAL HEALTH EFFECTS IN BOTH ADULTS
